On behalf of the St. Louis Regional Office of the American Arbitration Association, I am pleased to advise you that your application to join our Commercial Panel has been approved. Acceptance to the roster is conditioned upon successful completion of AAA training requirements. Training is provided by regional offices on a periodic basis. For information on upcoming training programs, please contact the regional office closest to you.

For 70 years, the American Arbitration Association has served the needs of the business and legal communities. In 1996, we made a commitment to provide ADR users with a panel of arbitrators and mediators of the highest caliber by making our Roster significantly smaller and more select. Your name will be submitted only on cases calling for your particular expertise or background, and you will not be called to serve until the parties select you to hear a case.

These reviews will be conducted at two-year intervals or sooner if deemed appropriate by the AAA.
