Foreclosure sales of real estate:

Neither the Circuit Court of St. Louis County, the Circuit Clerk of St. Louis County, nor the Sheriff of St. Louis County maintains or has access to any information concerning the sale of real estate that has been foreclosed upon by a mortgage lender. As a result, we can answer no questions about these sales.

While such sales are regularly conducted in the St. Louis County Courts Building, the sales are conducted near the north doors on the first floor (Plaza Level) in an area that is open and accessible to the public. Those sales are not scheduled by anyone in this building, and no list of such sales is maintained here.

In Missouri, foreclosure sales do not require judicial action, and no one affiliated with the Court plays any role in the process or has any information about the sales.

Nearly all such sales are conducted by a Trustee in accordance with the terms of the *Deed of Trust* on the real estate. In Missouri, virtually all real estate mortgages are accompanied by a *Deed of Trust*. You may learn more about Trustees, Deeds of Trust, and the requirements for sales by Trustees by consulting Chapter 443 of the Missouri Revised Statutes.

Tax sales:

Sales of real estate for unpaid taxes in St. Louis County are conducted once a year, on the fourth Monday in August.

(314) 615-3866 Tax sales are conducted by the St. Louis County Collector of Revenue. Again, no judicial action is required, and no one affiliated with the Court plays any role in the process.

Other information:

You may be interested to know that notices regarding real estate sales pursuant to deeds of trust and for unpaid taxes are published in *The Countian* or in the *St. Louis Watchman Advocate*.
